#### YOUR ANNUAL CONTRIBUTION

The most important single thing you can do to protect your own interests in your home is to make a contribution to your Association. The average received to date is over \$12 and the range is from \$5 to \$50, a good showing.

Ackerman donates his time and energy (and he has done so for 6 years) in his job as Secretary-Treasurer. Mr. Robert Mettner, 15957 Brewster Road has assumed some of Mr. Ackerman's duties, and he was elected unanimously Assistant Secretary and Treasurer of the corporation. In another year, we hope to relieve Mr. Ackerman of all of the detail work of correspondence, addressing and mailing, supervision of funds, work with property transfer, architectural and other committees. We are currently buying an addressograph machine and will need more office equipment. As has been the case in the past we can no longer expect the individual companies for whom officers work to contribute such services. They have been most generous.
