Lore of Forest Hill II: Taylor Boulevard

It seems as far back as 1938, there was confusion about north and south Taylor. In the March 11, 1938 edition of the Heights Press (the precursor of the Sun Press), the paper reported that Taylor north of Mayfield would be referred to as Taylor Boulevard, since many people neglected to add the "north" prefix. A complete name change was also suggested, perhaps changing South Taylor to "Taylorton." But then Cleveland Heights Mayor Frank C. Cain objected, arguing Cleveland Heights probably had the name first and shouldn't have to change it! Clearly the "boulevard" designation didn't stick, as we still refer to the street north of Mavfield as North Taylor Road. The address confusion between north and south Taylor hasn't gone away either. And we know that letters addressed to 2419 Lee Road (south of Mayfield) sometimes wind up at the FHHO offices at 2419 Lee Boulevard, so perhaps the boulevard solution wouldn't have worked any better than north and south designations. Maybe Taylorton wouldn't have been half bad!

What About Fences?

This topic always gets a conversation (or argument) going! It was as much an issue in the US Colonies, in the open prairies of the old West, as it is today. The subliminal message sent is, "Stay off my property!" That negative sentiment sets heat to the controversy. The Covenants established (and attached to the legal property records) for Forest Hill-Developed properties mandate that no fence or free-standing structure be erected on a property. This was established so that blocks would have an open, park-like center without obstruction.

The mandate has long been modified to accommodate an approved-type of fence *when all adjoining property owners or those within a sight line* agree.


In no case has a *stockade*, or *privacy* fence been approved in our neighborhood. Any owners who have erected those have made the statement that they do not want to abide by the cooperative agreement among neighbors. When a fence request is submitted to the FHHO Standards Committee, it is usually approved, providing that the fence is *style compliant*, i.e., three-feet tall or less and visually unobtrusive.

However, there will always be residents who want to do things their own way. Remember that the Covenants of Forest Hill Properties override any city permits. In the past, city permits have not been issued for roof, fence, or other construction projects without due process of FHHO.

We are issuing this statement as a reminder that our neighborhood standards can only remain high when neighbors themselves agree to comply rather than defy. If the standards had not been enforced through the past fifty years, you might not have chosen to invest in a property here. It is interesting to know that other neighborhoods are now trying to develop guidelines such as we have, in order to maintain quality in their area. Most new developments now have similar restrictions and residents willingly pay a mandatory monthly fee as well. In fifty years, what will these neighborhoods be like? Will the residents defy or cooperate with the long-standing restrictions? Cooperation is certainly more agreeable than litigation.

We hope that the caliber of residents in Forest Hill can show that we are considerate enough of our neighbors to live in a congenial fashion, whether it be noise, control of children, pets, or exterior construction.

Please think about your neighbors, your neighborhood and your community before beginning construction.

The Forest Hill neighborhood consists of 32 streets, with 31 that have residents. (Stuart Road does not have any homes.) Have you ever wondered how your street compares with the others in the area?

The streets with the most homes in the neighborhood are as follows:

- 2. Newbury Drive (62)
- 3. Monticello Boulevard (61)
- 4. Hereford Road (58)
- 5. Brewster Road and Forest Hills Boulevard (56 each tie)
- 6. Oakhill Road (53)
- 7. Rumson Road (51)
- 8. Chelsea Drive (49)
- 9. North Taylor Road (43)
- 10. Mount Vernon Road (42)

Wyatt Road and Walden Road are the least populated street with nine homes each. Seaton Road has eleven homes, Bolton Road has 15, Kew Road has 16 and Fenemore Road has 17.

As of our August 15, 2009 publication date, Chelsea Road and Rumson Road has 18 contributors to the Forest Hill Homeowners Association. Mayfield Road and Seaton Road each have only one contributor.

Because of the wide variety of street sizes, perhaps more important, is the relative percent of contributors.

Cleveland Heights Council Race Features Two Forest Hill Residents

With the early announcement that Council member Nancy Dietrich will not seek re-election to a new term in Cleveland Heights city council, a large group of candidates have filed petitions with the county to run for the four available seats. Along with incumbents Bonnie Caplan, Mark Tumeo and Forest Hill resident Edward Kelley, another Forest Hill resident, Cheryl Stevens has joined the crowded field.

Gary Benjamin, Mary Dunbar, Fran Mentch, Toby Rittner, Jason Stein and Keba Sylla have also pulled petitions, with the intent of filing. The petition filing deadline for Cleveland Heights is September 4, 2009. As of the writing of this article, a few candidates have not yet been officially filed their petitions with the Cuyahoga County Board of Election.

Because Cleveland Heights has a non-partisan election, all of the ten (or more) candidates will appear on the ballot. The top four vote-getters will win election to Cleveland Heights City Council.Heights H

East Cleveland Elections Features Two Forest Hill Residents

Current East Cleveland Ward 3 Councilman and Forest Hill resident, Gary Norton has decided to run for Mayor of East Cleveland against incumbent Eric Brewer. Because the East Cleveland mayoral race is partisan, a Democratic primary will be held on September 29, 2009. At the July 1, 2009 deadline, no Republican had filed, so a Republican primary will not be held. It is likely that the winner of the Democratic primary will be mayor of East Cleveland for the next four years.

The East Cleveland portion of Forest Hill is encompassed within the boarders of City Council Ward 3. Another Forest Hill resident, Chantelle Lewis has filed petitions to take Mr. Norton's place. She will run against Ephraim Abdullah and former council member, O. Mays, both of whom live outside of Forest Hill.

Three Candidates, Major Adams, Jr., Virginia Russell and Qumar Strowder will oppose incumbents, Joy Jordan and Nathanial Martin for a position as Council at Large. None of the candidates are Forest Hill residents.

East Cleveland Council at Large and Council Ward candidates run in non-partisan elections and so, will not face-off until the November 3, 2009 General Election.

Notes from the Forest Hill Historic Preservation Society

The Forest Hill Historic Preservation Society is lucky to be centered in an area covered by deed restrictions. Often times, historic properties are defaced, decimated and destroyed long before society realized the gem they represent. Because John D. Rockefeller, Jr. initiated Deed Restrictions at the inception of the community, most of the historic Rockefeller homes have suffered only minor infractions. In fact, in the petition for recognition of historic status, only a few non-compliant aspects were called out. We have been remarkably good guardians of history.

Our fortunes can and might change. Many of the residents who love and care for their Rockefeller homes are getting older. The demands of these complex homes require a younger mind and body. Some of the new generation of owners are less respectful of the history and the buildings. Gutters are removed and not replaced. Roofs are left with missing slate panels. Fences are erected using cheap materials and unskilled labor. An original mailbox is removed, replaced with a resin model from Home Depot and lost forever. It may seem insignificant, but long ago, the mansions on Euclid Avenue were at the height of desirability. Today, that is no longer the case.

The deed restrictions have prevented the removal of the steel casement windows in one house; they prevented the installation of a six-foot diameter satellite dish in the backyard of another. Still, deed restrictions, enforced by a voluntary staff and donated dollars cannot always overcome the obstacle and determination of those who think only of themselves and not the community good. The neighborhood has always been dotted by an abandoned home here and a neglected home there. We are now seeing owners blatantly defying the deed restrictions and the historic home they agreed to foster for the time they lived within.

A ride through the historic district will immediately illustrate the point. Well maintained homes are set along side of homes that are abandoned. Unkempt yards are connected to pristine landscaping. A cherry red fence has been installed without the benefit of a plum bob or level during constructed. Original toilets are left on the tree lawn for rubbish collection, without concern to their past.

We are only a few homes away from turning into the next Euclid Avenue. Yet, there is hope. Excited owners arrive each year. Conscientious owners, when forced to sell work hard to find good buyers. The Forest Hill Deed restrictions are at our back, assisting us as we try to keep a viable and relevant historic neighborhood. We are living in precarious times. Won't you help, or get out of the way of those who will?

Humans who have failed to neuter or spay their cats have created and untenable situation that has allowed a civilized society to imagine the viability of hundreds of thousands of euthanized domestic animals each and every year. Our abandonment of these former house pets has created feral colonies of cats, a living arrangement, whereby cats return to the wild and create a society outdoors. The cycle can be abetted and humans can help feral cats live a reasonable life in the "wild" with a little education.

A feral cat is an unsocialized cat. It was born outside. The likelihood of a feral cat moving to adoption is VERY slim. They avoid human contact and will be very poor pet. Feral cats brought into shelters, typically face euthanasia. Experts have determined that the only viable method to deal with feral cat colonies is a system called Trap-Neuter-Release (TNR).

We have all heard the arguments. Feral cats are filled with disease. Feral cats are bad for humans. Feral cats should be taken to the animal shelter. Feral cats spend the night yowling and fighting. Feral cats are the bane of my neighborhood. With a little education a little humane compassion, you can learn how to deal with the unfortunate byproduct of man's inhumanity.

Like all animals, Mother Nature has imbued cats with a desire to reproduce. By removing the drive to mate, a feral colony can live in peace. Add a sustainable source of food and it is unlikely that a neighborhood will know that a group of cats lives in the area, save the occasional sighting. TNR is a simple process. Feral cats are trapped and brought to a clinic for sterilization along with an assortment of vaccinations. After they have sufficiently recovered, they are brought back to their colony. Perhaps the cat will disappear for a short period, but they will ultimately return to enjoy a normal life.

It is estimated that there are over a quarter-million stray cats in Cuyahoga County. Failure to use TNR results in a "vacuum effect" — euthanized or removed cats are backfilled with another feline from the neighborhood and the breeding process continues anew.

The Cleveland Animal Protective League (APL) is making traps and sterilization available at a low cost. They also offer expert advice. The feline population in Cleveland (and the rest of the nation) is reaching crisis proportions. The key to their success in placing animals in loving homes is control of the entire population of domestic cats. A 16 week old female cat goes into heat and the reproductive cycle starts again.

Getting involved is simple. If you are aware of a feral colony in your area, contact the APL. They will do an assessment on the quantity of animals and the difficulty to help the feline community. On the day before sterilization

is scheduled, the trap should be set in a somewhat sheltered area. Once trapped, bring them to the medical facility. Information of low-cost spay/neuter can be found at www.clevelandapl.org.

Last year, the APL assisted TNR of 1200 cats. In April of 2009, they had already helped 700 cats. The TNR program has helped the Cleveland APL cut euthanasia in half over the last four years.

Once mating has been removed from the colony, only a steady supply of food is needed to prevent the remaining elements of annoyance. Alley Cat Allies, an advocacy group dedicated to helping feral cats, suggests feeding the cats at a regular time, during the daylight. Place only enough food for one meal and remove all of the remaining food after 20 minutes to avoid an insect or wildlife problem. A constant source of food will prevent destructive behavior as the animal forages for needed nutrition. A fully sterilized colony actually prevents strays from entering the area.

You can, of course do more. Insuring the animals have a warm place to stay during the winter months will make their outdoor existence habitable. A raised enclosure filled with hay could be considered. The space should be large enough to allow the cats to huddle together to maintain warmth. Be sure the opening is small, only large enough for a cat to enter and prevent predators from disturbing the group. It should be positioned in a protected area. Other tips are available on the Alley Cat Allies website www.alleycat.org.

The plight of stray and feral cats is the direct result of ignorant owners who fail to spay or neuter their pets. Their inaction has caused this chronic problem. Now, we need to deal with an issue almost unheard of twenty years ago. Consider doing what you can to help these unfortunate creatures.
