### Have You Heard...

#### **EAST CLEVELAND IS MOVING CLOSER TO ANNEXATION**

The Cuyahoga County Board of Elections verified on July 17th that petitions



submitted by East Cleveland Mayor Gary Norton contained enough valid signatures for the impoverished

suburb to proceed with a proposal to be annexed by the City of Cleveland.

In a news release, the elections board reported that East Cleveland had exceeded the requirement of collecting at least 559 valid signatures from registered voters who cast ballots in the November 2013 general election. Of the 1,613 signatures submitted, 827 of the signatures (51 percent) were certified as valid.

Both East Cleveland and Cleveland now have 30 days to each appoint three commissioners to negotiate the terms of any annexation. The commissioners will have 120 days to come to an agreement. Only four of the six must agree in order to proceed. If at least four commissioners agree on terms, both cities will have another 30 days to certify the issue to the Board of Elections. If the elections board receives the issue by December 16, 2015, voters in East Cleveland would consider an annexation issue on the March 15, 2016 primary ballot.

If East Cleveland voters approve the proposal, Cleveland City Council members would either vote to adopt the terms or send the issue to the ballot in their city.

I also attended the special community forum with Cleveland Heights City Council members in which there was a discussion of turning the CH Water Department over to a private company. There were 200 CH residents at the meeting and the vast majority vociferously opposed that idea. The problem remains as to how CH will be able to pay to repair the underground leaks which are costing so much in lost water.

The FHHO Board has recently presented gifts of Sharon Gregor's "Forest Hill: The Rockefeller Estate," signed by the author, to FHHO members who donated at the Platinum Level – with our sincerest gratitude. We are also in the process of planning a party to honor those who donated at the \$125 and above level. Thanks to all those who have sent in their 2015 contribution.

easy to let the needed repairs to your house slip past your attention. We come to summer with enthusiasm about all that needs to be done to take care of winter's ravages to our homes: filled and fallen gutters, peeling paint, slipped slates on our roofs. But the traveling, family gatherings, concerts and cookouts take our time, and soon the weather cools and the repairs are not completed.

### Forest Hill Action Committee

It been almost a year since Forest Hill residents met to discuss the state of over 50 homes in Forest Hill that were in distress. Since that meeting the committee has researched several options to address many of the issues raised and is currently in

discussions with a Real Estate lawyer about representing FHHO. His role would be to begin legal notification to the 20+ current bank-owned properties and demand compliance with FHHO and either fix up and/or sell the problem home immediately. The law firm would collect their fees from the lien holder or owner.

The committee is also working with a couple of prospective investors to match up with the distressed properties once legal action begins and the bank or owner moves to divest the property.
